Eligibility: 11 & under: Players born on or after Jan 1, 1997

10 & under: Players born on or after Jan 1, 1998

9 & under: Players born on or after Jan 1, 1999

8 & under: Players born on or after Jan 1, 2000

Note: Players may "play up" a division if desired. If player plays up at the Sectional Level,

then the player must continue to play up at the Regional and National Level.

Surface: Indoor and Outdoor Hard Courts (*non-marking soles required*)

Scoring: Two out of three sets with regular scoring and 3rd set Super Tie Breaker for 9, 10, and 11 & under.

Ten game pro-set with regular scoring and tie-breaker for 8 & under.

Match Time: First match times will be available on Tues, May 27 by calling 972-2237

Awards: Trophies will be awarded to 1st, 2nd, and 3rd places in each division.

Ribbons will be awarded to Consolation Winners & Finalists
